- Online Course Fee Policy**
1. Students enrolled **exclusively** in eligible online courses may request exemption from the following fees:
 - Campus Development -Student Union-Bond -Fitness Center
 - Student Government/SGA -Student Union-Operations
 2. All students must pay the Computer Lab Services fee.
 3. Students exercising this option will not be issued a Mountaineer Card and will forego the rights to services and extracurricular benefits provided through these fees.
 4. Students enrolled in at least one credit of non-online or ineligible courses must pay all mandatory fees for all credits enrolled, including online course credits.
 5. Online courses, as used in this policy, are defined and designated as such by the Academic Affairs Office.
